

The unrelated organization and filing organization used the Form 990 of similar exempt organizations, compensation surveys and studies, and approval by the board to determine compensation on an annual basis. The two organizations have a technical service agreement for such administrative services.

Form 990, Part VI, Section C, Line 19:

The Organization's governing documents, conflict of interest policy, and financial statements are available to the public upon request.

Form 990, Part IX, Compensation:

The Organization reports compensation but does not file any W-2 forms. Compensation was paid by the Archdiocese of Dubuque, an unrelated organization, for services to The Catholic Foundation in the Archdiocese of Dubuque. The Archdiocese of Dubuque submits the W-2 forms.
